



"UNIQUENESS OF INDIAN CONSTITUTION"

Indian Constitution "the extreme code of law of the Indian Subcontinent" is as much unique in its structure. Right from the beginning of its introduction i.e. from 1950 January 26, it became the world's largest written constitution, which is itself its unique feature. The Indian Constitution is the "soul of Indian Subcontinent". As a country like India with different cultural and linguistic diversities, the role of constitution is prominent for the overall development of nation. The moral and spiritual ethics of constitution made it unique as compared with rest of the world. The most adaptable feature of Indian constitution



is its efficiency in serving the public. As the chairman of Drafting Committee, Dr. B.R. Ambedkar himself took a keen interest in making the constitution strict and to make it as an efficient tool to control the nation in its day to day survival.

Certain factors which made the constitution unique, out of which the most important feature is its "adaptability". Indian constitution is easily adaptable in a wider sense. As the preamble of the Indian Constitution clearly states that "India is a sovereign, secular, democratic, independent and Republic in its dealings. Likewise the Indian constitution provides a keen interest in "socio-cultural" activities and the ethnic cultural diversity of India.



Arising from the central sphere of society, our constitution "strictly enforces codified laws to protect the overall developmental and institutional aspects of the society". The most astonishing feature of our constitution is its "rigidity". Indian constitution is rigid in its appearance and working. The rigid nature of Indian constitution is visible in its extreme sense of nature used to control social misbehaviours. As we all know that, "Indian constitution is the largest written and lengthiest constitution in the world". This also paved a way to its uniqueness. It can be amended only by the parliament of India under certain procedures mentioned in the constitution itself. This shows its hard inflexible nature. "The Indian concept of secularism" which is mentioned in the Indian constitution is also a unique feature of Indian constitution. As compared with Western Secularism, in Indian Secularism government keenly intervenes in religious activities which how far reduced religious discrimination. Indian Constitution provided Freedom of expression to its citizens.
